He proposed the introduction of a special currency, the "Ionian Drachma" which had no backing whatever, so as to obtain the complete drain of every resource or wealth of the land; the measure succeeded so well that immediately after the collapse of the Italians the whole population was left destitute.

Corporal EMILIC NAPOLITANO, private SALVATORE and pvte CARMELO serving in Grete during the occupation are responsible for the following war crime with the result of the murder of an unknown British pilot P.O.W.

On July 23.1943 a British plane piloted by an unknown pilot made a forced landing at Helona district of Frima Karambelo. An Italian unit arrived on the spot. The unit included the above mentioned three Italians. The detachment neared the plane which was on fire, but seeing the pilot fleeing, started firing on him. The British pilot answered with his revolver.

ELILIO NAFOLITANO and CARMELO managed to kill the British pilot and stripped him of everything he was wearing.
